1. Changes to the Senior Leadership Team

2. OFSTED

(a) Expectations

It has become clear to everyone who has been inspected that "the bar has been raised by Ofsted" since September 2016. There is now a higher expectation on schools to achieve "better than expected progress" for all pupils. As Plymouth CAST we are committed to developing appropriate structures and support mechanisms, including the sharing of best practice between CAST schools, to enable you all to achieve the standards expected of you and your pupils in a fast-changing world.

(b) Congratulations

The Board wishes to send well deserved congratulations to all schools graded "Good" under the new inspection criteria. Please identify examples of best practice to share with your colleagues.

To those schools graded "Requires Improvement". You have received positive feedback on many aspects of your work. We are confident you are establishing firm foundations on which to build and inspire your pupils to greater success in the future.

To those schools graded "Inadequate", please continue to strive for excellence. We are committed to you receiving the appropriate support and guidance to ensure that all pupils receive the challenge and support they need to make better than expected progress.

3. Buildings and Facilities

Capital works and facilities management across CAST is currently delivered by Strictly Education. This contract will finish on 31 March 2017. The contract will run as normal up to and including that date; any open orders or work still in progress on that date will continue under transitional arrangements on a case by case basis. CAST Support are in the final stages of negotiating a new contract with a new service provider. It is hoped to announce the award of this contract before the end of February in plenty of time for commencement on 1 April 2017.

4. Budgeting and Service Level Agreements

Budget setting for the next Academy Financial Year is upon us. When considering Service Level Agreements (SLA) schools are reminded that SLA's for both Human Resources and Finance support must be placed with CAST support from 1 September 2017. Where this is not contractually possible, or contracts expire before 1 September 2017, then the switch should be at the earliest possible opportunity.
